- Plan and actively participate in Office of Spiritual Life-sponsored programs, including:
 - Interfaith Dinners
 - Religious Prayers and Festivals
 - o Hope Center and Spiritual Life Programming
 - Inter-campus communications
- Engage in ongoing interfaith literacy activities to deepen understanding of both personal and diverse worldviews.



- Actively seek opportunities for personal growth and learning about different religious and non-religious perspectives.
- Attend Interfaith Team meetings (schedule to be proposed) and actively participate in discussions and planning.
- Collaborate with fellow Interfaith Peer Educators and staff to coordinate and execute programing effectively.
- Attend all aspects of designated training, including sessions scheduled in spring, fall, and ongoing throughout the year.
- Stay informed about best practices in interfaith dialogue and community building.
- Engage in leadership development opportunities across campus to enhance personal and professional skills.
- Actively contribute to the growth and success of the interfaith community.
